1. Warranty Period and Details

Subject to the provisions of this Warranty, Flat Glass Industries Ltd warrants that the Product, for a period of 2 years from the date of manufacture:

- Will conform with the relevant quality, thickness and dimensional requirements of AS2208:1996.
- Will not fail to function due to electrical failure and/or delamination of the panel.
- Will not fail where the Product is of adequate thickness for the design wind pressures as specified by the Buyer in accordance with Australian Standards AS1170 and AS1288.
- Will not delaminate or edge separate greater than 12mm from the edge
- Will remain free from visual or visible defects, faults and inclusions which can be clearly seen from a distance of 3m away and which are not within the limits as laid out in AS/NZS 4667:2000

2. Warranty Coverage

This Warranty is to be read in conjunction with the FGI “Terms and Conditions of Sale” currently in force.

This Warranty which only provides for free replacement of the Product or refund of the original invoice value, accepts no liability for personal injury, loss, claims, property damage, or labour, material or other costs (whether special or consequential or otherwise), howsoever caused or arising and whether direct or indirect.

3. Compliance to Standards

All Product conforms with the applicable sections of Australian Standard AS2208.

4. Conditions

The Warranty is further subject to the following conditions:

- a. That the Buyer acknowledges that the Product at the time of delivery was undamaged and free from any defects.
- b. That the Product is protected from contact with wet cement, hard foreign objects, metals and materials likely to cause abrasive damage.
- c. That storage, handling and cleaning of the Product is entirely in accordance with FGI recommendations as published by FGI and the glass components are not damaged in any way before or during installation.

Concéale Glass Warranty

Flat Glass Industries Ltd (FGI) hereby provides the following Warranty in respect of its Concéale Switchable Glass (“the Product”).

- d. That the Product is not exposed to chemical fumes or gases other than those present in normal clear atmospheric air nor exposed to radiation of any type other than normal sunlight.
- e. That the Product is not subject or likely to be subject to stresses from any cause in excess of the stresses advised as acceptable in FGI literature or in specific correspondence.
- f. No further edge working, processing, cutting or processing is attempted or takes place. The warranty only applies to product which is the same size, shape and form as originally supplied by FGI.
- g. If the Product is intended to be installed where it will be subjected to excessive moisture then it is imperative that all the edges of the panels are properly sealed prior to framing with the appropriate edge tape and non-acetic, neutral cure silicon sealant.
- h. The product is not installed in a manner whereby the Product has prolonged exposure to moisture/water at the glass edge. The product does not have exposure to temperatures greater than 70°C
- i. The glazing sealants used are compatible with the laminated interlayer. Use only neutral cure silicones. DO NOT use acetic silicones. Please consult FGI for further details.
- j. The panels must be in the 'OFF' state (opaque) for a minimum of four (4) hours every twenty four (24) hour period.

5. Reporting and Verification of Product Failure

FGI has the right to establish to its satisfaction that the Product deterioration or failure is in accordance with the above Warranty and that all of the above conditions have been met.

Any failure of the Product shall be reported immediately to FGI to enable the Product to be examined in situ by FGI to determine cause of failure and if failure of the Product is not notified to FGI within seven days of failure, the Buyer shall be deemed to have waived all rights under the Warranty (subject always to the full terms and conditions of this agreement).

6. Exclusions

The Warranty specifically excludes any glass breakage from any cause other than faulty materials up to the specified design wind pressure

as determined in accordance with Australian Standards AS1170 and AS1288, and specifically excludes any consequential liabilities following installation.

Subject to limitations imposed by the Trade Practices Act, this Warranty is in substitution for and to the exclusion of all other rights and remedies (if any) and FGI makes no Warranty on merchantability or that the Product is fit for any particular purpose or use.

7. Warranty of Replacement Product

Any replacement Product supplied pursuant to this Warranty shall be warranted only until the expiration of the Warranty period for the original Product.

8. Advice
